3 **Resolution supporting S. 1033 and H.R. 2330, the Kennedy/McCain Bill to improve**  
4 **security and immigration.**

6 WHEREAS, The Secure America and Orderly Immigration Act (S. 1033 & H.R. 2330),  
7 sponsored by Senators John McCain and Edward Kennedy, would allow people to change  
8 their immigration status within the United States, encouraging immigrants to legally reside in  
9 the United States; and

10 WHEREAS, The Act provides a path to permanent residency while securing a legal  
11 path for future immigrants; and,

12 WHEREAS, Immigrants have contributed to the strength and prosperity of the United  
13 States by making significant economic and cultural contributions; and,

14 WHEREAS, Federal immigration policies should uphold the United States' tradition as  
15 a nation of immigrants and reaffirm our nation's support and commitment to the family unit,  
16 economic opportunity, fair work conditions, and respect for all humanity; and,

17 WHEREAS, Recent proposals have criminalized undocumented persons living here  
18 today, proving ineffective in serving the people of the United States and protecting the  
19 national security of our United States; and,

20 WHEREAS, The United States cannot effectively carry out its national security policies  
21 unless the United States identifies undocumented immigrants and encourages them to come  
22 forward and participate in the legal economy of the United States; and,

23 WHEREAS, S. 1033 and H.R. 2330 is on file with the Clerk of the Board of Supervisors  
24 in File No. 060259, which is hereby declared to be a part of this resolution as if set forth fully  
25 herein; and,

1           WHEREAS, The Irish Lobby for Immigration Reform held a town hall meeting at the  
2 United Irish Cultural Center; now,

3           WHEREAS, The San Francisco Board of Supervisors acknowledges the leadership of  
4 Congresswoman Nancy Pelosi, who is one of 18 House co-sponsors of the bill; and

5           WHEREAS, San Francisco has always been a "City of Refuge" for immigrants; now,  
6 therefore, be it

7           RESOLVED, That the San Francisco Board of Supervisors encourages the US Senate  
8 and House of Representatives to approve the Secure American Orderly Immigration Act,  
9 (S. 1033 and H.R. 2330), and urges the President to sign the bill as soon as possible; and, be

11           FURTHER RESOLVED, That the Board of Supervisors directs the Clerk to send a copy  
12 of this resolution to our federal representatives and the offices of the sponsoring senators.




