RESOLUTION AUTHORIZING THE APPLICATION TO AND ACCEPTANCE OF THE ELM CITY RESIDENT CARD GRANT AWARD FROM JUNTA FOR THE PURPOSE OF PROMOTING AND ISSUING THE ELM CITY RESIDENT CARD FROM JULY 1, 2012 TO JUNE 30, 2013.

WHEREAS, the New Haven Health Department recognizes the importance of providing New Haven's residents with the ability to obtain an Elm City Resident Card;

WHEREAS, the City of New Haven will apply for funding from JUNTA; and upon receipt of such grant, the City will accept said grant in its entirety;

WHEREAS, JUNTA has allocated funding for the City of New Haven Health Department intended for the fifth anniversary of the Elm City Resident Card and ongoing community outreach to revitalize the card. JUNTA, the City and other area nonprofit organizations will provide community education regarding the card, canvassing regarding new ideas for the card, and assisting the City with signing up residents for the card. Work to be carried out under this project, including the promotion and issuance the Elm City Resident Card will be done in part by the City of New Haven Health Department;

NOW, THEREFORE, be it RESOLVED by the Board of Aldermen of the City of New Haven that the Mayor, on behalf of the City, is authorized to apply for and accept the grant mentioned herein from JUNTA.

BE IT FUTHER RESOLVED that the Mayor is authorized to execute said application for funding for an amount of \$13,000 and to execute any revisions, amendments or modifications to said contract.
